Why do we need your photographic image and/or video?

How do we collect your photographic image and/or video

Where do we store and protect your information?

All photographic images and/or videos are retained by the Equalities & Communications Section at Tayside Contracts and held securely on Tayside Contracts' secure servers.

The HR Services Team will have access to your photos/videos for the purposes of recruitment advertising.

Sharing your information

Photographic images and/or video could be published in our printed documents such as our Annual Performance Report, digitally on our website and other websites such as Indeed and on social media websites such as Facebook, Instagram, LinkedIn, X and our YouTube channel.

Photographic images and/or videos published on websites and on social media can be accessed by anyone from anywhere in the world.

Legal basis for processing your information:

We will only process your photographic image and/or video for marketing purposes with your consent.

You are under no obligation to have your photograph taken or be videoed for marketing purposes and there will be no consequences as a result of not participating.

You have the right to withdraw your consent at any time and should you wish to do so, we will stop processing your photographic image and/or video in any new printed material and remove the photographs published digitally.

How long we keep your photographic image and/or video for marketing purposes

Photographic images and/or videos will be retained in line with Tayside Contracts retention schedule which details the length of time records should be kept. At the end of this period the images and/or videos will be destroyed or deleted in line with our confidential destruction procedures.

Your rights regarding the personal data we hold about you

Data protection legislation gives you certain rights in relation to your personal information.
